Thank you for your message and your interest in our supply chain due diligence efforts. We understand the growing public interest in this topic and appreciate your commitment to responsible sourcing.

We would like to inform you that we do not currently provide information based on the Extended Minerals Reporting Template (EMRT) or the Additional Minerals Reporting Template (AMRT), as there is no legal obligation or generally accepted industry standard requiring the reporting of supply chain information for minerals covered by the EMRT (e.g., cobalt, copper, nickel) or AMRT. Furthermore, for reasons of confidentiality and data protection, we do not publish supplier-specific information on these raw materials.

Nevertheless, sustainability is a central component of our corporate strategy. We are committed to exercising due diligence in the supply chain through targeted cooperation with our suppliers and the continuous improvement of sustainability standards throughout our entire value chain. We aim to continuously improve transparency in our supply chain and therefore work with stakeholders, including experts, industry consortia, competitors, and customers, to fully exploit the potential in this area.

In accordance with the legal requirements of the German Supply Chain Due Diligence Act (LkSG), we have introduced a comprehensive process for identifying and addressing actual or potential human rights and environmental risks in our supply chain. It is important to note that, unlike 3TG minerals (tin, tantalum, tungsten, and gold), for which there are legal reporting requirements under the US Dodd-Frank Act Section 1502 and the EU Conflict Minerals Regulation (EU) 2017/821, there are no corresponding legal requirements for EMRT and AMRT. Our process involves regularly reviewing our suppliers based on relevant industry and country risks and monitoring for signs of non-compliance. We take preventive and, where necessary, corrective measures to mitigate risks. Further corrective and risk-mitigating measures are implemented based on the severity of the violation.

We value our partnership and look forward to continuing to work together.
